Why is it important?

Good engagement helps you to:

- Meet your due diligence obligations
 - You have a handle on what is happening
- Manage risk
 - People sharing information
 - Discussion about hazards/risk/controls
- Improve workplace culture
 - Around health, safety and wellbeing

Keep things simple Manage real world risks

It's the basics that make work safer. By keeping things simple you can take action around the issues that matter.



Keep focused on the big stuff that is most likely to hurt people. Forget the crazy what if, never in a million years risks.



Make everyone responsible

Making sure everyone knows how they can make a difference. If things are risky, they need to speak up. If there is a plan to stay safe, you need to follow it.



The stuff you need to discuss first

- How will you engage effectively with each other
- Agree health, safety and wellbeing goals
- How you manage hazards/risks and controls
- What authority do the Workers have?
- How to celebrate

The stuff to discuss ongoing

- Review progress Review any Stories/StoryAnwhere told:
 - Are there any immediate corrective actions
 - What needs to change
 - Are the corrective actions working
 - When it is closed out (i.e. problem fixed)





The stuff to discuss ongoing

- Review existing and new risks and their controls:
 - Focus on the critical/serious ones first
 - Is there a shortage of resources
 - Do people take shortcuts?
 - Is the solution practical and followed
- Review the Gear (Plant and Equipment)
 - Does any need repaired/serviced/replaced
 - Do you have correct PPE and other safety equipment

Initiating Discussion Example 1

- People in a room for Team Meeting
- Give person No. 1 an object (e.g. Magic Pen)
- Everyone else is to be quiet.
- The Magic Pen cannot be passed on until they have said three things about health and safety:
 - Something positive (nice) that happened
 - Something about a risk they work with
 - Something they learned or could have done better



Initiating Discussion Example 2

People in a room for Team Meeting

Get everyone to load a StoryAnywhere on the

App.

They have to tell a StoryAnywhere about:

- A shortcut that was taken
- When they were short of resources
- When a hazard/risk was created by someone else
- Something positive (nice) that happened



Initiating Discussion Example 3

 Discuss an incident that has occurred (e.g. press release)

Ask:

- What risks contributed to the incident?
- Were the controls adequate?
- Could the same thing happen in our business?
- What do we need to change?





Example Incident - 1


- Brakes on second hand tractor supplied by farm machinery business failed and ran over a worker
- The brakes were not working when the farm machinery business bought the tractor
- Some repairs were carried out when it was delivered to a property for a trial
- The farm owner identified further issues with the tractor, including its brakes which were fixed
- Brakes failed 5 days later




Example Incident - 2

- A worker sustained back injuries, after the freight cage he was working in fell 3m from forklift tines
- The cage did not comply with industry standards
 & had not been attached to the forklift correctly
- There were documented safety systems that were not being implemented in the day to day running of the business
- Workers were not being appropriately communicated with
